China Vows to Step up IPR Protection for Animation Works

In an effort to support creation, production and broadcasting of animation works through application and examination, step up IPR protection and promote the commercialization, the Ministry of Culture, the State Administration of Radio, Film and Television, and the General Administration of Press and Publication jointly issued a Circular on Declaration of State High-Quality Animation Works Project recently.

Under the circular, the three authorities would receive the application materials for the project starting from August 1 to September 30. Any domestic legal person or registered group engaging in animation production in China could file a request. The circular also requires the authorities to support the projects by establishing a commercialization promotion platform, organizing public education and strengthenning IPR protection.

China Software Industry Generates 1.3 Trillion Yuan in 2010

Thanks to the campaign against infringement and piracy software, and promotion of use of licensed software, China's software industry generated 1.3 trillion yuan in revenue in 2010. As of now, the remediation campaign for use of authorized software by central government agencies concludes as scheduled. 135 national-level and local agencies have spent 377.14 million yuan in purchasing 381.807 sets of authorized software. The local government will fulfill the tasks before the end of October.

Huawei, ZTE Face Possible 337 Investigation

On July 26, three companies under the digital giant Intel Corporation filed applications with the US

International Trade Commission (ITC) for initiating a 337 investigation, alleging Huawei Technology and Zhongxing Telecom Equipment Corporation (ZTE), China's two leading telecom solution providers and the Finish mobile giant Nokia over infringement of 7 patents in 3G wireless equipment and sought an exclusion order.

As their first 337 investigation case, Huawei and ZTE both signified that they would take the dispute seriously. Huawei said that they owned a large quantity of core patents in 3G and 4G technologies and always attached great importance to IPR protection and have a good reputation in respecting and protecting IPR since they started their business.
